NOTICE OF ANNUAL MEETING 2011

The Annual Meeting of the First Congregational Church of Lebanon, New Hampshire will be held in the church sanctuary on Sunday, February 13, 2011, immediately following the worship service, for the purpose of:

1. The election of all officers provided for under the CONSTITUTION AND BY-LAWS of the church:

3. The following changes to the Constitution are recommended by the Church Council:

ANNUAL MEETING MINUTES FIRST CONGREGATIONAL CHURCH

Sunday, February 14, 2010

The Call to Order

Meeting was called to order by Bob Moses.

Invocation

Invocation was given by Pastor Stephen Silver.

Reading of the Warrant

A Motion was made and seconded to dispense of the reading of the warrant. The motion passed.

Reading of the Minutes

A Motion was made and seconded to dispense of the reading of the minutes. The motion passed.

Reports

All committee reports were presented and accepted as submitted.

The congregation stood as the names of those who have contributed to the endowment funds were read.

New Business:

Motions made to make two changes in the by-laws. Both motions approved.

First motion: Memorial Garden Committee:

Purpose: The Memorial Gardens Committee shall be responsible for the over site and maintenance of (1) The Howard Memorial Garden surrounding the church sign in front of the church and (2) Internment Garden in front of the Memorial Stone where members may have their ashes intered. They shall provide a setting for the acknowledgement of contributing members.

Scope: The Memorial Gardens Committee shall be responsible for making sure the policies and guidelines for care and internment are followed, in addition to:

Seeing that proper and accurate financial and internment records are maintained.

Seeing that both gardens are maintained.

Arranging for the burial place for the internment of ashes.

Overseeing and approving any planting that is done in either garden.

Membership: The Memorials Committee shall consist of three members, one elected each year at the annual meeting for a term of three years.

Second Motion: Calling a Pastor:

In the event a need arises to call a Pastor, a Pulpit committee of the First Congregational Church of Lebanon will be formed to fill this vacancy. The Pulpit committee will be nominated by the Chair of the Church Council and approved by the Council. The committee will serve until a vote of approval by the congregation at a meeting called to approve the candidate to become the next pastor of the church.

In securing pastoral services during the period of a vacancy, the Diaconate will be responsible for providing coverage as described under Scope within Article V, Section 2.

The Pulpit committee may request that the Conference minister secure relevant information about any candidate whom it wishes to consider for the vacancy.

The Pulpit committee will present the candidate it recommends to the Church Congregation, which determines by vote whether it wishes to call the candidate recommended. Preceding the vote of the Congregation, the candidate will lead the worship service and preach a sermon to give the congregation a chance to evaluate the candidate.

The terms of the call agreement will be negotiated between the financial advisory subcommittee of the Church Council and the called minister. The finalized call agreement will then be presented to the Church Council for approval. Following signing by the Church Council Chair and the minister called, a copy of the call agreement will be filed in the Church office and also given to the minister called.

When a Minister accepts a call to the First Congregational Church of Lebanon, the Minister and Diaconate will join in requesting the Grafton-Orange Association arrange for a service of installation or recognition.

If the First Congregational Church of Lebanon selects a ministerial leader who does not have standing in the United Church of Christ, the minister may seek dual standing from the Grafton-Orange Association or UCC ordination.

REPORT FROM THE MINISTER: 2010

Introduction

It's hard to believe, but this is my second annual meeting as your minister and pastor. While I had nothing to report at my first meeting, having been on staff for but a few days when the 2010 session was called to order, I have much to share with you this year. What follows are some highlights from our common life together these past twelve months. Before proceeding, however, let me note that numbers are expertly provided elsewhere in the Clerk's Report (we now have more than 200 covenant members on the books); the Treasurer's Report (the finances are sound); and the Board of Governor's proposed budget (we are trying to do a lot while being good stewards of what has been placed in our care). If you are looking for fellowship and committee reports, I encourage you to read the entire annual report: you'll learn a lot – and hopefully be inspired to become more involved in an area of the church you love or to explore one that intrigues you.

Getting to Know You

My entry into life as your pastor was facilitated by the incredible hospitality extended by so many members of the congregation. Throughout the late winter and into the spring, I was blessed to be welcomed into so many of your homes for meals and the opportunity to get to know you. While the months apart from Rachel and Chip were difficult, these dinners were a treat.

Another way in which I've gotten to know you is through our work together on committees, boards, and in fellowship groups. I have been impressed by the dedication and faithfulness that you bring to your work for the church. As I've noted before, in our polity, we are all ministers; you serve each other and the community in a way that reflects your appreciation of this truth!

Are we done getting to know each other? Not by a long shot. But this first year has been a great start, and I look forward to deepening my relationship with each of you in the coming year.

Church School Refurbishment

One of the most exciting and satisfying developments during the past year was the transformation of our church school area. One of the things that drew me to First Congregational was this church's love of children; I still remember noticing the children's library in the parlor during my first visit to FCC (as did Chip, during his!). And after my arrival in Lebanon, I quickly learned how blessed we are to have Marcia Corkins as our church school director. Still, it was clear that something was missing for our children and that was a space worthy of them. The church school area – what we called the basement – was long in need of some attention. When I proposed that we take action, the response was enthusiastic and determined. Within six months, the money was allocated and donated, walls and ceilings were repaired and painted in inviting, appealing colors, and the carpets were all replaced. The result is a space this is welcoming to children and their families and that reflects the value we place on our youngest members and our children's ministry.

Communications

Web/Electronic Presence 2.0

"If you're not virtual, you're not real" is one of the odder realities of 21st century life. Over the past year our website was completely redesigned by Robin Cushman. This project was launched with one clear goal in mind: to use the Internet as another means of sharing our mission and ministry with the Upper Valley. Visitors to our site can now learn about our congregation, listen to sermons, read past issues of the newsletter, and view pictures of events in our common life. Keep an eye on our website in the coming months as ministry and devotional resources are added.

In addition to recreating our website, we initiated weekly email updates. These messages have enabled us to keep members of the church apprised of upcoming activities and events taking place at the church. My hope is that some of you are also forwarding these communications on to friends who might be interested in learning about our church community.

Welcome Brochure

We published a new, full-color welcome brochure this year to tell others about who we are. This project was the result of much hard work on the part of many people – but it's worth it. I was at the Co-op just the other day and what did I see in the information racks? Our brochure!

Picture Directory

Sometime in the near future our brand new congregational photo directory will arrive for distribution. This project required more work and coordination than one might imagine! What made this effort truly notable, though, is the way it was used to contact and reengage members of our church. We were able to speak with people we've not seen in a while and determine whether people felt they were still members of our church family. It turned out to be a great way for us to strengthen our community.

Discernment Process

Last spring our church launched a congregational discernment process with the goal of learning where it was God was calling us to go and who God was calling us to be. The investment the congregation has made in this process has been remarkable. Volunteers served on a committee that met throughout the year; your church leadership met in retreat twice; more than sixty households participated in individual conversations about our church; scores came to an all-church forum. Throughout, people have been faithful and honest. Our process comes to a close with this annual meeting, but the work will continue through our committees, boards, and fellowships. The desire to grow deeper in faith and community, to grow younger in both people and spirit, and to grow through action in mission all came through loud and clear. Our challenge as a faith community is to now act on what we have learned.

Personnel

When I came on board last winter, the position of Administrative Assistant was vacant. We were fortunate when we hired Robin Cushman, who in a very short time revamped our website and brought our publications to a whole new level. Add to her technical abilities a warm and engaging personality and she was a wonderful addition to our ministry team. It was thus with deep regret but complete understanding that we received Robin's resignation to leave for a full-time opportunity with benefits. Imagine our delight, when within a month of Robin's departure we found and were able to hire Janet Schoeler, who brings an excellent set of skills and a very engaging personality to the position. We're delighted to have her as part of our ministry team!

I would be remiss if I did not note here what a pleasure it is to have Will Ögmundson and Marcia Corkins as part of our ministry team. Will brings talent, flair, and faithfulness to his music each week. He also brings a willingness to experiment and try new things. I am especially grateful to him for composing the Sanctus that we are now using during communion each month. This short piece of music brilliantly captures the celebratory nature of the Eucharist. We are truly blessed by Will's presence among us.

And Marcia? She brings a potent combination of faith, experience, and love to her work with our youngest members. Kids who find themselves in our church school have no doubt that they are indeed treasured children of God. This is no accident! Again, we are truly blessed by Marcia's ministry with our children.

Challenges ahead

Growing young and new without losing what we value from the past and present

The profile put together by the church and the information we have received from the congregation during the discernment process make clear a desire for this church to grow younger. This is both a healthy attitude and an organizational imperative. If the church doesn't attract new families and new people, it will stagnate and ultimately die. Nobody wants that to happen. So, we will have to change and evolve, trying new things and exploring new ways. But as we do this, we don't want to lose touch with our past, which is one in which we can take great pride and from which we can draw inspiration. It is vital that as we move into the future, all members of our congregation feel that they are valued, that they have things to contribute, and that they are encouraged to help shape our common future.

Finances

In many ways, we are in an enviable financial position. Stewardship giving is up and our endowment is strong. Yet we cannot afford to become complacent. Our endowment, while expertly managed, is still subject to the vagaries and whims of the wider financial world, a place of marked instability as we've all been reminded these past few years. If we truly seek to make our visions for the future become reality, we will need to further increase our stewardship giving. My hope and goal is that we as a community will delve deeper into what it means to be stewards, not just of money, but of all God has entrusted to our care. Ultimately, when people give to the church, my prayer is that it is out of joy, excitement, covenant with neighbors, and a sense of vocation, not duty or obligation.

Physical plant

It's not surprising that members of our congregation take such pride in our church. Our beautiful building was the first major commission of Ammi B. Young, who would become a noted architect whose work can be seen not only on the green in Lebanon, but at Dartmouth College and in Boston's Financial District. Our meetinghouse has served us well since 1828, and we all expect it do so into the future. But for this to happen we will need to care for our entire building – not just the meetinghouse itself but the vestry, parlor, kitchen, offices, and lower level, including the space beneath the sanctuary. We will need to be good stewards of this special building's history and heritage while meeting the needs of a 21st century worshipping community. Fortunately, we have a talented, dedicated Board of Governors to leading our efforts to develop a master plan for the care, maintenance, preservation, and adaptation of our facility.

Final Thoughts ...

One thing I refrained from doing in my report was naming particular volunteers. This isn't because I don't value what you do, but because there are so many of you (and you do so much) and the risk of missing someone is very, very high. So, let me note here my deep gratitude to each and everyone of you for all you do, whether it involves music, numbers, physical plant, kids, the wider church, mission, anything. This church works – indeed, it thrives – because the members of the congregation have heard and accepted God's call to worship, service, witness, and fellowship in this community and throughout the Upper Valley.

REPORT OF THE DIACONATE for 2010

"We believe in God the Father, infinite in wisdom, goodness and love, and in Jesus Christ, his son our Lord and Savior, who for us and our salvation lived and died and rose again and liveth evermore. We hold it to be the mission of the church to proclaim the gospel to all mankind exalting the worship of the one true God. We believe in the freedom and responsibility under God of the individual and in the right of private judgment. We hold to the autonomy of the local church and its independence of all ecclesiastical control."h

Following the annual meeting, the diaconate met briefly to elect officers as follows: Chair: Shelly Moses; Secretary: Carolyn Crocker; Cards and Flowers: Carolin Bassett; Treasurer: Nora Miller; and for Pastoral Relations committee: Carolyn Crocker. Mark Rowell's valued contribution as deacon necessarily changed when he began his field work at the Congregational Church of Lyme; he continues as our Student in Care. Ike Jacobs was welcomed back onto the Diaconate to fill the vacancy. We have enjoyed the participation of our junior deacons in our meetings, worship, and activities.

In this first year of Steve Silver's pastorate, we have responded to new ideas for worship and congregational life and provided explanations of our history and traditions. We seek to strengthen the community by continuing conversations on issues and concerns, listening to multiple points of view, and taking action. We also strive to open the fellowship to newcomers and to make worship an experience in which congregants participate fully.

To these ends, we have begun the use of churchwide nametags; developed a welcome brochure; generated a new picture directory; made changes in the communion service; and sought feedback from church members. Thanks to former deacon ("once a deacon always a deacon") Karen Morganelli, the usher/greeter schedule has been faithfully and smoothly maintained.

Many special activities have involved the diaconate: Steve's installation service June 20; the Leadership Retreats; the Discernment process; the all-church forum; assistance in serving the AppleFest pig roast dinner.

The traditional work of the deacons, "to provide funds and physical assistance for those in need" has been sustained through individual and group efforts. The diaconate has set aside funds for the support and training of the Called to Care committee, under Nora Miller's leadership. Carolin Bassett has reached out to members and friends of the church, in crisis and celebration, through her ministry of Flowers and Cards. Through the Communion offering, neighbors in need have been assisted by the church's BackDoor Ministry, in coordination with local agencies. We also supported the environmental work of James Scott in the coral reefs of the Philippines.

First Congregational Church has participated fully—often with Steve Silver preaching and hosting the Thanksgiving Eve worship —in ecumenical and community services. We reach out to the community, through simple things like the open front doors and new events and services like the Blessing of the Animals on the front lawn and the three varied opportunities for worship on Christmas Eve. As deacons we seek to share our faith, welcoming newcomers, strengthening the bonds of fellowship within the church family, and sharing our blessings with the larger world.

Summary of 2010 activity:

The Church continues to be blessed with the thoughtfulness and generosity of members past and present. The names of the benefactors listed on the following page truly allows the Church "to do good, both within and outside the walls of this building", as Reuben Cole wrote many years ago and is repeated annually in the Trustees report. In 2010, the Church received a substantial bequest of \$500,000 from the Estate of Elaine Cook. Elaine became a member of the First Congregational Church of Lebanon as a child and served in too many capacities to list. However, one of her last roles was to serve as a fellow Trustee. During those years she provided grace and wisdom that shall be missed.

The endowment funds of the Church are primarily invested in the Consolidated Investment Fund of the New Hampshire Conference, which in turn has selected United Church Funds ("UCF"), the investment arm of the National United Church of Christ, as its investment manager. The investments managed by the UCF are invested in their Moderate Balanced Fund. This fund invests approximately 60% of its assets in equity instruments and 40% of its assets in fixed income instruments. During 2010, the Trustees opened an account directly with UCF and invested \$500,000 into the Moderate Balanced Fund. The investment results for 2010 totaled 12.20%, which was slightly in excess of their benchmark return. As shown on the historical analysis of endowment funds, the overall investments of the Church managed by the Trustees now total \$2,169,729.

The Trustees have adopted a spending policy to limit trustee withdrawals from unrestricted endowment funds to no more than 5% of principal on a three-year rolling average. This amount is consistent with endowment funds of other institutions. Our three-year rolling average of total distributions currently totals 4.86% which is slightly less than our 5% goal.

The Pastors Endowment Fund is the property of the Church. However the income earned on this endowment are used to fund a savings plan for our pastor to assist with housing costs in retirement. During 2010, all income was reinvested into new shares for Steve's benefit.

The Trustees in 2010 also received a final distribution from the Estate of Earle and Mary Burke in the amount of \$2,896.12. In addition, an income distribution in the amount of \$18,406.97 was received by the Clifton and Edith Waldo Trust. The Church Council authorized expenditure of these unexpected funds towards Sunday School and basement improvements. The Trustees are unsure as of this writing if the Church will receive additional distributions.

The Trustees are equipped to accept gifts of stocks. The Trustees welcome the opportunity to answer questions about gifts to the Church of stocks or bequests to the Church by will.

The importance of Trust Fund income to the survival of this Church and its capability to serve its membership and its community can not be over emphasized. As in former years, included in this report are the names who we remember as providing the wherewithal which produced the resources that in significant part enables this Church to do good, both within and outside the walls of this building.

CHURCH HISTORY 2010

"There is nothing <u>wrong</u> with America that can not be changed by what is <u>right</u> with America!" With this quote, seen on television, I find enthusiasm to complete this history of life in our church in 2010. We have accomplished a lot!

<u>January</u> was a month of transition. We moved from the season of Advent to Epiphany. The sanctuary was cleared of the window lights, the tree and wreaths as well as the children's crèche and the memorial needlepoint banner of the nativity, which hung from the balcony. Soon it was time to say farewell to our interim minister, Rev. Louse Bastille. She was a very devout and caring lady. She served us well in our transition from out long time pastor, teacher & friend, Rev. Richard Salter who was with us for twenty-five years, to our new settled pastor Rev. Stephen R. <u>February 7</u> was Boy Scout Sunday. The boys were greeters, ushers and read the scriptures. The guest minister was Heidi Hoskins. The Service was preceded by the Boy Scout Breakfast. There are a good number of boys in Troup #279, which our church has sponsored for many, many years. <u>February 14th</u> was the sixth and last Sunday after Epiphany and Rev. Silver's first Sunday as our pastor. It was also the Annual Meeting at which Rev. Silver was duly welcomed followed by lunch for all. On <u>February 17</u> at 7:30pm Rev. Silver joined the local clergy in an Ecumenical Ash Wednesday Service at the West Lebanon Congregational Church. The following Sunday was the first Sunday of Lent. On Sunday <u>February</u> <u>28th</u>, twelve from our congregation traveled to the Trinitarian Congregational Church, UCC in historic Concord, Massachusetts, for a service of ordination. "The Pie Ladies" were very successful in February, making a \$450.00 Profit. In April they made \$300.00. The Christian Education Committee also had a very successful project. Denim clothing was collected to be used as housing insulation when rebuilding homes in areas devastated by natural disasters such as hurricane and tornadoes. A Guinness

World Record was set by the collection of denim clothing. 33,088 items were collected from around the world. Our church collected well more than 10 boxes of denim with the enthusiastic leadership of Trish Heatherton. Another fine event in April was the addition to the church staff of Robin Cushman, as Administrative Secretary. She has updated the look of our monthly newsletter and put it online, thereby saving both paper & postage. She also has worked diligently on the website. During the time that Rev. Steve has been waiting for his wife and son to be able to make the move to Lebanon, some of us were able to take advantage of this time for "food and friendship". These 'dinners of discovery' were a pleasant way of getting to know each other.

This might be a good time to remind everyone of some of the behind the scenes gatherings that take place each month. There is choir rehearsal every Thursday evening at 7pm. Also there is bible study every Saturday morning from 9am to 10am. Women's Fellowship is at 7pm the first Monday of the month, and the Men's Breakfast is at 8 am the first Saturday of the month. Every Wednesday from 6 to 7pm the UVPRN meets. The Diaconate meets at 7pm the second Monday each month. And the Board of Governors meets at 7pm every second Tuesday each month. The community dinner is served at 5:30 in the First Baptist Church the second Wednesday each month. A small group, Barb Laro, Marcia Corkin and Irish Heatherton and other volunteers as needed prepare the food on Tuesday and heat and serve it on Wednesday. Members of the church are invited to donate supplies for each dinner or to make a monetary donation. On the second Thursday of each month the Clergy of the Grafton/Orange Association meet at 9:30 until 4pm for Bible Study and committee meetings. And finally on the fourth Saturday of each month the Lebanon Food Share Committee meets from 7am to 10am. The Lebanon Recreation Dept sometimes uses the vestry and kitchen. For a group of quilters and the sanctuary is used as a rain date location when needed in the summertime.

At the May Council Meeting Rev. Steve introduced the <u>congregational discernment process</u>. This process, which would continue throughout the year and include two retreats of your church leadership, individual conversations with more than 60 members of the congregation, and an all-church forum, will is designed to help the First Congregational Church of Lebanon discern where God is calling it to go and what kind of church it should be. The Congregational Discernment Committee, comprised of Linda Jacobs, Todd Miller (chair) Shelly Moses, Susan Reade, Barry Schuster, Jon Scott, Leslie Zagarolla, and Steve Silver (ex-officio) will be concluding its work with a report to the congregation at the 2011 Annual Meeting.

<u>Sunday May 4th</u> was the fifth Sunday of Easter. On <u>Monday May 5th</u>, some of the Women's Fellowship prepared and served a beautiful and delicious lunch to celebrate the senior members of the church. They were further entertained by the Superlatives, the Lebanon High School singing group. On <u>May 18th</u> we were saddened by the death of Elaine Cook. She was a long time, active member of our church and was beloved by many. On <u>Friday May 21st</u> the Women's Fellowship served a Lasagna Dinner. It was well attended and the different kinds of lasagna were very much enjoyed! <u>May 23rd</u> was Pentecost Sunday and there was a church birthday party, complete with cake and ice cream on the front lawn after worship. Later that day, there was a Dedication for the Habitat for Humanity House, which was recently completed. On <u>May 30th</u> we observed Trinity Sunday. The Church School area closed for a summer of renovation including cleaning, wall repair, painting, and the installation of a beautiful but sturdy new carpet.

June saw four of our young people graduate from high school. Elizabeth Moses on May 29th from K.U.A, Josh Goodrich and Julia Janson on June 10th from Lebanon High School and June 18 Tyler Boice graduated from Hartford High School. On June 4 Dr. Gordon Place was recognized for his thirty-five years of dedicated service as a Commissioner on the Lebanon Housing Authority. He was Chairman of the Board of Directors for thirty of those years. This dedication occurred at Romano Circle at the completion of a second unit call Romano <u>Place</u>. A new road was built, connecting these two units and named "Doc Place". Doctor Place and his lovely wife, Laura, have been very substantial "pillars" of our church for over fifty-six years. On Sunday June 6th the new deacons were installed during worship service. June 12, the Lebanon High School celebrated Alumni Day with a parade of the former classes. The Women's Fellowship took advantage of all the activity in Colburn Park and again was successful in selling homemade pies. <u>Sunday June 13th</u> was Children's Day Bibles and other gifts were given. The children made ice cream sundaes during fellowship/coffee

hour. June 20th was Fathers Day/Shelter Sunday, at which time money was donated for the Habitat for Humanity in honor of in memory of special men in our lives. This was also the Sunday that the Grafton/Orange Association conducted the Installation of the Rev. Stephen R. Silver as the 21st minister of the First Congregational Church of Lebanon N.H., UCC. That very special ceremony was followed by a reception at which clergy of the Grafton/Orange Association and members of our congregation, as well as family and friends of Rev. Steve could congratulate him. On Monday evening June 28th at 7pm we were again entertained by an outstanding piano concert by our very special minister of music, Will Ögmundson. This is a good time to briefly mention the Memorial Garden. These gardens were planted on Memorial Day weekend, and are maintained by the Memorial Garden Committee: Pete Mason, Chair, Ike Jacobs and Carolin Bassett. Any church member may have a small amount of their ashes buried in the garden and their name engraved on the monument. During the summer we have been able to follow James Scott, a K.U.A. student, as he worked with the Volunteer Coral Cay Conservation Expedition in the Philippine Islands. He participated in a six-week program of the CCC to "help conserve one of the most precious and delicate natural resources on the planet" and "to help the local communities to develop a sustainable and environmentally responsible way to support their communities. James enjoyed seeing many different kinds of fish, from barracuda, shark and dolphin to massive jellyfish, baby eel and pipefish. He enjoyed working with people from Saudi Arabia, England, Wales, Germany, and of course the Philippines. We appreciated sharing this experience with James. One of the exciting events sponsored by the Mission and Social Action Committee was the Bike and Build Program. Over twenty young people traveled by bicycle from Vancouver Washington to Portsmouth New Hampshire. They were at our church from Friday June 25 to Saturday evening June 26, when they made a presentation to church members. They related stories about the work they had accomplished over some sixty-nine days. It was inspiring to hear of their dedication and commitment to this project. While here they worked on the current Habitat for Humanity House. They camped out in our vestry along with their bikes and enjoyed the meals provided by the Mission Committee. This is just one of the many ways that our church is used. We can worship God in many ways and may we do this for years to come.

On <u>Sunday July 4th</u> we celebrated communion and Independence Day. There had been a knitting group started which meets on the second and fourth Wednesday evenings at 7pm. This is for knitters of all skills and for those who wish to learn. Some of us even do some sewing. Its very informal, you can bring a friend not connected to our church except by friendship. On July 27 and 28 Olan Mills were set up in the vestry to take photographs of church members to be published in a soft cover booklet along with addresses, phone numbers and e-mail addresses. Each member or family will receive a directory as well as an 8x10 photograph. This directory makes it easier for us to call each other and to more easily identify newer members.

The first <u>Sunday of August</u> was on the first, and we gathered at 9:30 in Colburn Park to unite with the folks from the Lebanon United Methodist Church. This is always a very pleasant and joyful worship service. On <u>August 1st</u> there was also a most enjoyable picnic at the lake home of Beth Griffiths and Ken Steinke. As always, they were very gracious hosts and a happy time was had by all. On <u>Friday August 6th</u>, there was an outstanding organ recital by Alan Saggerson, a delightful Englishman. He is the organist and director of music at St. Mary's with All Souls Parish Church in London, England.

<u>September 5th</u> was communion Sunday. Olan Mills were with us again on <u>September 10 and 11</u> to finish taking photographs. Now we will await the finished product. <u>September 12th</u> was the exciting day when the children returned for the "Kick-Off" of church school. A new event was the "Blessing of the Backpacks" (featured on the front page of the next day's Valley News) that was followed by a 'gourmet' meal of macaroni and cheese and hot dogs! On <u>September 25</u>, there was the big event to which the church and community look forward. Frolic, fun and feast ~ The Annual Apple Festival and Pig Roast!! This was an all-church event, where each board and committee had a specific job to do. The aroma of the pig roasting kept everyone anticipating that evenings feast. On <u>Sunday September 26th</u> the entire church family was invited to the parsonage for refreshments and fellowship. We were delighted to see the finished product of all the work done by the Board of Governors. We are very pleased that our pastor and his family are happy and comfortable

in their new home. In September all of the boards and committees resumed their labors. Also in September Rev. Steve formed two groups of young people who would gather twice a month on Sunday evenings for food and friendship. These junior-high and senior high students would discuss topics which interested each group while they devoured their favorite food -PIZZA!

The forum was instituted on <u>October 3rd</u> by Rev. Steve for the purpose of discussions, classes and lectures on topics relevant to our faith. The first series was a four-part program entitled Christianity 101 followed by explorations of Judaism, Islam, and Buddhism and Judaism ~each in 50 minutes! <u>Sunday October 3rd</u> was the CROP walk. This annual event has been supported by our church since it was first organized by Beryl and Leif Thorsrud many years ago. <u>October 3rd</u> was communion Sunday. On <u>October 17</u> at 3pm there was a blessing of the Animals. This is often done by churches on the Feast Day of St. Francis of Assisi that this year was on <u>October 4th</u> but that was a busy day so it was celebrated later in the month. The NH Conference of the United Church of Christ held its annual meeting on <u>Saturday October 23rd</u> from 9am until 7:30pm in Concord NH. Your delegates attended. On <u>Sunday October 24th</u> there was the fall meeting of the Grafton/Orange Association of the UCC in Post Mills Vermont. That same Sunday there was an all-church forum on the discernment process to exchange ideas on where and how we want our church to move forward.

On the first <u>Saturday</u> in November, the wonderful men of our church hosted their usual "Men's Breakfast" and invited the rest of us to join them. Then at 9am everyone was assigned to certain areas and began their chores. It was the Annual Fall Clean-Up Day! They cleaned the sanctuary and swapped cushions from the balcony with some in the sanctuary, which had been spotted with wax. They also vacuumed around the pews. In the office they did something with wiring and modems and a router ~ whatever that stuff is. Downstairs they painted bookshelves, removed junk around the breaker box and cleaned more junk from under the sanctuary. Outside they trimmed hedges, raked leaves and repaired floodlights. During November there were a series of sermons on stewardship, entitled "Taking Care of Business". Steve wrote, "God has called us to be stewards. ~ Some of the things that God has entrusted to our care are time, money, creation and community". On the Sundays in November, he informed us thusly:

November 7 - Time - Ecclesiastes 3:1-8 November 14 - Money - I Timothy 6:6-10 November 21 - Creation - Genesis 1:26-30 November 28 - Community - Acts 4:32 and 5:11

<u>Sunday November 28th</u> was the first Sunday of Advent. The nativity banner was hung from the balcony. The candlelights were placed in each sanctuary window and the first advent banner was hung. The church looked extremely nice in the evening with the lights shining on the trees and in each window in the front of the church --- including the bell tower. Thank you Todd Miller and Ike Jacobs. We also appreciated the lit tree in the Sanctuary, which Tom Morgan helped Todd to put up. The pastor and the young teens had pizza and conversation that first Sunday in November. The church school theme for the current year will be friendship. The youngsters would learn how to be a faithful friend. On <u>November 19</u>, 50 women from our church and surrounding communities traveled to Hartford Connecticut for a two-day conference. The Women of Faith conference sent those ladies home with great enthusiasm, light in their eyes and hope in their hearts full of FAITH! On <u>Wednesday evening November 24</u> our church hosted the Ecumenical Thanksgiving Eve Service. Many from surrounding churches attended and enjoyed simple refreshments and friendship following the service. The first <u>Sunday of Advent was November 28th</u>. People were still full of turkey but were already looking forward to Christmas.

<u>December 5th was the Second Sunday of Advent</u>. The second Advent banner was hung and the Second Advent candle was lit. The Women's Fellowship hosted a Christmas gathering on <u>December 6th</u> for the whole church family. A very enjoyable time was enjoyed by all as we sang carols and consumed very tasty refreshments. <u>Sunday December 12th</u> was Pageant Sunday. This year, several <u>adults (and one youth)</u> from our congregation portrayed Shepherds, the Three Kings, a Woman, and a "Wise Kid" who told the Kings where to go! There was a lunch following worship service.

<u>December 19th</u> was the Fourth Sunday of Advent. From 3 to 5pm that afternoon there were Christmas Stories for the children, teens and young at heart at the parsonage. At 7pm that same day there was an Ecumenical Blue Christmas at the United Methodist Church of Lebanon. That was a quiet service of prayer, reflection and music for those having difficulty during this season. Steve offered the meditation. On <u>Tuesday December 21st</u> from 5:15 to 5:30 there was the twenty first "Annual Homeless Persons Memorial Candlelight Vigil". <u>Friday December 24th</u> we had three Christmas Eve services. A Family Service featuring a children's pageant (and a very full house) was offered at 5pm, a Traditional Service of Lessons and Carols was held at 7pm and communions was shared at the 11 pm Candlelight Service. <u>Sunday December 26</u> was the first Sunday after Christmas and Friday was New Years Eve.

We pray that the year of 2011 brings good health and happiness to the church family and that they reach out with caring to others in the community. May our church grow in numbers and discipleship.

This concludes a compilation of news and events in our church during the year 2010. We continue to enjoy and marvel at the great talent of our minister of music, Will Ögmundson. Our new pastor gives us much to think about during each Sunday Worship.....How does Steve do it every Sunday without reading any notes?! We are very blessed by both of these fine young men and we appreciate God's Blessing.

I am, as always, very honored to have been asked to perform this task for our church.
