MINISTER'S REPORT 2012

Introduction

As I reflect upon our common life this past year, I am struck by a recurring theme: attending to infrastructure. While this may not sound exciting, the reality is that what it makes possible for individuals and the community, both here in the church and beyond our doors, has the potential to be transformative and life-giving. I believe you find ample evidence of this, as you read this report and its descriptions of how we have been tending to infrastructure both physical and spiritual.

I encourage you to consult the Clerk's Report (we have more than 200 covenant members and friends of the church, both old and new); the Treasurer's and Trustees' Reports (even after being subjected to significant demands by the needs of our meetinghouse, our finances are sound, thanks to faithful, wise management); the Finance Committee's proposed budget for the coming year (our faith community continues to hear a call to do great things while being faithful, careful stewards of the resources entrusted to our care); and finally the reports of our various fellowships and committees, which bring to life the many ways that our members and friends live out the Gospel.

Attending to Infrastructure (or Building the Kingdom)

Caring for our meetinghouse

During 2011 it was determined that the time had arrived for a new roof on the meetinghouse. Before proceeding with this project, however, a structural engineer was brought in to evaluate the structural integrity of our facility. While his report was positive, we learned of the need to attend to the trusses and supports in the space above the sanctuary. This work was done during the early summer of 2012.

As we moved into the fall program season, we believed that our work on the sanctuary was done; then an earthquake struck Maine, with aftershocks felt here in the Upper Valley. Evidence of this seismic event was immediately visible in the sanctuary ceiling, leading to the determination that the ceiling was potentially in danger of collapse if subjected to further stress. That led to the sanctuary ceiling restoration project, which is still underway as I write this report.

While the work itself has ably been done by outside contractors, the unsung heroes of this story are our Board of Governors, Trustees, and Finance Committee, who had to make a series of complex decisions involving significant investments on a very tight schedule. The wisdom, grace, and good humor they brought to these projects are heartening—though not surprising.

As if the work on the sanctuary were not enough to keep our members busy, there was the parlor project. An ad-hoc Decorating Committee, drawing its members from across the congregation and authorized by Council, shepherded the redecoration of this vital community space from initial conversations about potential designs to completion of work, all in six months. The project included painting walls, laying new carpet, choosing and hanging new window treatments, and more. I am exceedingly grateful for the great effort devoted to this project by the members of this team.

The work in the sanctuary and parlor, it should be noted, wasn't ultimately about deferred maintenance or changing tastes; it was about making our church fit for the worship of God and the building of Christian community in the 21st century. As we all know, while our historic building is architecturally significant, its primary value lies in providing our faith community a venue in which to live out our shared call to be a vibrant outpost of the Kingdom of God. The projects described above do this and can thus be seen as acts of stewardship and praise.

Caring for our wider community

This past year our church undertook new initiatives based on the results of the discernment work we did as a congregation, while it continued to invest in long-standing service activities.

During the discernment process, the congregation made known its desire to focus efforts on a project close to home and one farther away. After surveying the congregation and meeting with representatives from local organizations, Second Growth and WISE emerged as the best candidates for an ongoing local partnership. After each organization made a presentation, those who attended gathered to discuss which one should be our partner. Rather than choose one over the other, however, it was agreed that we as a church had the ability and the call to work with both, given the complex interplay between the issues and challenges that Second Growth and WISE address. Our community has begun to develop its relationship with these organizations, starting with easy-to-execute projects but looking towards deeper engagement around issues.

Looking farther afield, steps were also taken to choose and develop a partnership with an organization not in the Upper Valley. After presentations and much discussion, and working with feedback from the congregation, the Mission and Social Action Committee decided that FCC Lebanon should build on its already extant relationship with the community of Los Naranjos, El Salvador. Areas for partnership include building a house, funding a scholarship, and learning about life in a very different part of the world.

As we have embarked on new areas of service, we have continued to develop and nurture other activities. Of special note, there is the monthly Community Dinner. Though this program may be just a year old, it has become an important part of the life of our church and that of many of our neighbors. This ministry serves both those who come to enjoy a meal and those who prepare it, and it is a moving example of how, by meeting at table, people from different walks of life can come together in Christ.

These activities, along with the CROP Walk, the Christmas Giving Tree, and one-time disaster response efforts, are often thought of as mission work. But I believe that they are also a form of pastoral care, to be seen as complementary to the work done by our Deacons, our Called to Care program, and our Prayer Team. Through different types of service, all are intended to care for the people of God, reflecting through the work of members of this church the love of our Creator. Individually and collectively, these ministries maintain and enhance the spiritual infrastructure of our community of faith.

Personnel

After Wendy Windsor left us last February to pursue another professional opportunity, we were fortunate, indeed blessed, to be able to hire Allison Schuster as Interim Church Administrator.

We knew at the time she'd be with us just a few short months but during her stay she was a welcome, valued presence in the office. I am especially grateful to her for the work she did migrating our newsletter from an outdated, hard-to-use design program to one that is current and easy to use. The benefit of her efforts was clear when her successor Brian Clancy moved into the Administrator's Office and began producing the newsletter, among other publications.

Speaking of Brian, I would like to offer him as a rebuttal to the old saying that lightning doesn't strike twice in the same place. We were lucky to have someone of Allison's caliber working in the office on an interim basis. To have a second equally skilled Interim Administrator has been a blessing. During his time in this position, Brian has contributed much to our community, providing invaluable support not only to me, but to our fellowships, committees, and outside users of our building.

As in past years, it's my pleasure to thank Will Ögmundson and Marcia Corkins for their ongoing ministries among us. We are blessed each week by what Will does with music in both worship (and performances: how many churches have a musician who can stage a twelve-hour piano-playing marathon?) and by what Marcia does with and for our children in Church School.

Finally, I will quote these words from last year's Annual Report, and fully expect to do so in years to come: "While our many volunteers are not personnel in the legal sense of the word, they are an indispensible part of our ministry team. My heartfelt thanks to each and every person for the time, talent, and love they give to the church, whether it's by baking a pie, balancing a checkbook, teaching a child, the list goes on. Thank you, thank you, thank you."

Challenges and Opportunities Ahead

Growing younger, growing deeper, growing outwards

These were the three headline goals that emerged out of our discernment process. In many ways, large and small, we have been living into these goals. I believe, though, that these should be seen as more than organizational goals but as our call as a faith community. In the months ahead, through preaching, discussion, and dialogue, I hope and pray we will be able to do this.

Volunteers and organizational structure

Last year I wrote, "This year our congregation will be filling more than 70 different volunteer positions, drawing from a congregation of just over 200 members and friends. We are asking a lot of our volunteers and need to be mindful of this. Every person who offers up his or her time should be nourished and fed by the committee on which he or she serves or the fellowship in which he or she participates. Involvement in the life of the church should be experienced as a vocational opportunity, not an unpaid job. How we go about ensuring this in the future will require flexibility, creativity, trust and faithfulness."

This has not changed. But I see this challenge as an opportunity. Our polity, rooted in the Congregational Way, lifts up the priesthood of all believers. As we move forward, I believe that collaborative models that fully empower the laity to do ministry will be central to our success. Such models will have to be developed organically, honoring our church's traditions while meeting the needs of an ever-changing congregation.

Public witness

Almost two months have passed since the shootings at Sandy Hook Elementary School in Connecticut. In this time, I have spoken from the pulpit and at the State House about the deeply disturbing problem of gun violence in our society. While doing so, especially when taking a stand outside of our doors, I have endeavored to be clear that I was speaking for myself and not for the church as a whole. This has raised an issue, though, one that I believe we as part of the body of Christ should consider prayerfully and faithfully: how are we as a Christian community called to speak out on particular issues, whether it's the role of weapons in our lives or the way in which we fully welcome all of God's children into our churches? This discussion will require everyone's participation. It will also require honesty, patience, charity, and faith. Thankfully, I believe God has blessed us with these things.

Conclusion

Life in the Upper Valley in recent years has shown us that while infrastructure maintenance can be complicated, prolonged, even infuriating, it's vital to ensuring the health and vigor of our community. What is true of Route 12A or our water mains is no less true of our church, both here in Lebanon and around the world.

If we are to remain vital, able to meet the needs of our congregants and our neighbors, we need to maintain our infrastructure, both physical and spiritual. Sometimes this will involve restoration, and other times replacement. When projects are completed, things may look just as they did at the beginning of work, or they may have a radical new form. Hopefully, though, they will serve to strengthen our ability to live into the Gospel of Jesus Christ and to share this good news of God's reconciling, healing love, with one another and the world.

AUDITOR'S REPORT

I have reviewed the accounts held by each committee within the church. The committees and their treasurers are as follows:

For the above accounts I was provided with receipts, as appropriate, and bank statements. These accounts all balanced with the bank statements.

To the best of my ability I reviewed the books of the Trustees, which are maintained by Bob Moses. Bob was available for the review and answered all questions asked of him. His books are well organized and detailed.

I also, to the best of my ability, reviewed the books of the Treasurer, Marcy Chong. She provided me with her bank statements and the receipts she had available. Some of her receipts are in the form of emails requesting reimbursement and she provided me with those when asked. There was one instance where a payment appeared to be made twice. I believe this was inadvertent. The party involved has been notified and will reimburse the church.

I have a concern regarding emails requesting reimbursement without the receipts, bills, or copies of such to back up the email requests. I suggest that if an email request is made, the receipt, bill or copies of such should also be furnished before the reimbursement check is written. This is necessary to show the legitimacy of the request. I also suggest that all check numbers be written on the appropriate corresponding receipts. This might, at the very least, help track any questions in the future about which receipts correspond to a given check.

To Marcy's credit, it is her first year as Treasurer and the system being used is a newer system than was used previously. Marcy was able to answer all of my questions very satisfactorily. I thank her for all of her hard work this first year and for her patience while I reviewed her books.

I appreciate the efforts of all the committee treasurers, of Bob and his excellent records and care of the Trustees' accounts, and for Marcy as she wraps up her first year as the church Treasurer.

DIACONATE REPORT

In 2012, as "servants of the church," the Deacons focused on the Discernment goals of Growing Deeper, Growing Outward, and Growing Younger, under the leadership of Deb Scott, chair. Valerie Nevel served as treasurer, Carolyn Crocker as secretary and representative to the Pastoral Relations Committee, along with Jesse Wingate (until June 2012) and Deb Scott.

In addition to Jesse, who married and moved to Virginia, Ken Reade stepped down in November. We are grateful to them for their dedication to our church and its ministry. Our gratitude and appreciation are extended to deacons who are completing their terms in 2013: Shelly Moses, Jon Scott, Betty Tedeschi, and Mark Yeager. We thank them for their faithfulness, dedication, and service. We look forward to continuing to serve with those Deacons who will continue their existing terms, those who will begin additional terms, and those joining us starting in 2013. Our youth members were Eric Petersson and Tori Nevel.

Devotions, Bible study, and the spiritual disciplines focused the work of the Diaconate in monthly meetings, as members sought to share our faith and to meet the physical and spiritual needs of our congregation and neighbors.

Deacons contacted members on their lists prior to the Lent, Easter, and Christmas seasons and throughout the year as needed. Susan Montmagny has capably led Called to Care, and Betty Tedeschi has kept the Prayer Team informed of requests and needs. Members of the Diaconate have brought communion to housebound members. Karen Morganelli has continued the work of finding greeters and ushers.

The Diaconate continued to meet with and provide prayerful support for Student-in-Care Mark Rowell as he completed his field and seminary work, began his clinical pastoral education at DHMC, and prepares for ordination.

Fellowship pads in the pews were adopted after a 3-month trial run, to enable the congregation to know one another. A confirmation class has been scheduled. The new, continuing and retiring deacons will hold an all-day spiritual and planning retreat on Saturday, February 9, at the Meriden Congregational Church, and a family-friendly, all-church retreat is being planned for the fall at Horton Center, the facility operated by our New Hampshire church conference's Outdoor Ministries program.

The monthly Communion offerings have supported our congregation's "Back Door" ministry with food vouchers and gas cards, Called-to-Care training, and a Christmas donation to WISE families in need, as part of the Church's partnership with WISE. A \$1,000 donation to the Upper Valley Haven was symbolized by 100 Share-the-Spirit sacks, which were made available to

the congregation. Sale of STS sacks resulted in another gift to The Haven. Thanks to Jen Petersson for leading this effort.

Individually, the deacons have led and participated in the monthly Community Dinners, and as a group, we were tasked with set-up for the Apple Festival on Saturday, September 29. Individual deacons also assisted with the Christmas Eve services.

As we seek to serve our church and community, the deacons welcome your suggestions and ideas.

Summary of 2012 Activity

The Church continues to be blessed with the thoughtfulness and generosity of members past and present. The benefactors listed on the following page truly allow the Church "to do good, both within and outside the walls of this building," as Reuben Cole wrote many years ago, his words repeated annually in the Trustees report.

The endowment funds of the Church are primarily invested with the United Church Funds (UCF), the investment arm of the national United Church of Christ. Our Church has invested into the Moderate Balanced Fund, which is a balanced fund that invests approximately 60% of its assets into equity-type investments and 40% into fixed-income-type investments. We have invested funds both directly with UCF and indirectly through the New Hampshire Conference. The investment management fees for a direct investment with UCF are slightly less.

In 2012, the Trustees began a diversification policy and transferred \$25,000 quarterly from the NH Conference UCF-invested funds to the Vanguard Wellington Fund, a fund that the Trustees established initially to invest a substantial bequest many years ago, and which also has a policy of investing approximately 60% of net assets into equity-type investments and 40% into fixed-income-type investments. At the end of 2012, approximately 88% of the Church's investments were invested through the UCF, and 9% was invested in the Vanguard Wellington Fund. The balance of the Church's funds (3%) consisted of cash.

The Trustees are pleased to report that the 2012 investment results approximated 13%. The UCF has not published its investment performance for 2012; however, based on one of our investment funds where our dividends are reinvested, it is projected to be approximately 13.1%. The Vanguard Wellington Fund returned 12.67% for 2012. These returns are extremely meaningful to the Church, especially as we have had substantial capital improvements the last few years and have budgeted approximately \$100,000 in 2013 to replace the sanctuary roof and to repair the sanctuary ceiling. I also continue to serve on the NH Conference investment committee, which allows me to participate in quarterly meetings with UCF personnel.

The Trustees have adopted a spending policy to limit trustee withdrawals from unrestricted endowment funds to no more than 5% of principal on a three-year rolling average. Our policy is consistent with endowment funds of other institutions; however, there is a trend to reduce the withdrawal rate as long-term performance has not met expectations for the last decade. The 2012 investment returns are a welcome change. The Trustees have considered reducing the policy withdrawal rate; however, given the substantial amount of capital improvements the Church is currently undertaking, it is not feasible to do so at this point in time. Our three-year rolling average of total distributions currently totals 4.94%, which is slightly less than our 5% goal. As shown on the historical analysis of endowment funds, the overall investments of the Church managed by the Trustees now total \$2,241,355, and support of general operations and capital improvements from the endowment approximated \$68,000 in 2012.

The Pastors Endowment Fund is the property of the Church. However, the income earned on this endowment is used to fund a savings plan for our pastor to assist with housing costs in retirement. During 2012, all income was reinvested into new shares for Steve's benefit.

The Trustees are equipped to accept gifts of stocks. The Trustees welcome the opportunity to answer questions about gifts to the Church of stocks or bequests to the Church by will.

The importance of Trust Fund income to the survival of this Church and its capability to serve its membership and its community can not be overemphasized. As in former years, included in this report are the names of those whom we remember as providing the wherewithal which produced the resources that in significant part enables this Church to do good, both within and outside the walls of this building.

BOARD OF GOVERNORS REPORT

It is prescribed by the Constitution and By-Laws that the Board of Governors shall have general charge and care of the physical properties of the church. The members of this board take these duties seriously, and it is our intent to accomplish these tasks to the best of our ability each year. As of last year, the responsibility for the budget was moved to the Finance Committee.

Our Sanctuary is currently in need of a new roof. When the Board of Governors looked into having new shingles installed, we discovered that the support structure for the roof was too old and weak to support the weight of either the shingles or the construction. We consulted the architectural firm of Tirey and Associates and developed a plan. Construction to strengthen the roof structure and bring everything up to code was completed by Trumbull Nelson in May and June of 2012. It became clear, though, that while the physical support of the roof was now in excellent shape, the plaster ceiling of the Sanctuary was not. We proposed that the Sanctuary ceiling be secured—work which has begun in January of 2013—and then new shingles be put on the roof in the spring of 2013.

Heating the church on extremely cold days has been a problem. The Sanctuary is heated with forced hot air provided by two furnaces dedicated to this job. However, since there is no insulation in the Sanctuary, it is difficult to maintain steady temperatures. We are working on ways to address this problem.

The rest of the church spaces (Parish Hall, kitchen, offices, and Church School rooms) are heated with forced hot water provided by a boiler. In fall of 2012 the boiler was found to be in bad shape, and Shawn Sleeper installed a new boiler in late November. A chimney liner will be installed in February 2013.

There is a beautiful old light hanging on the front porch. Photographs show this fixture in place since at least the early 1900s. This fixture was refurbished by Conant (Burlington, VT) and re-installed in May. Its wiring was also brought up to code.

The Spring Church Clean-up Day was postponed due to construction. The Fall Clean-up Day was held Saturday, October 13, and lots of cleaning, scrubbing, dusting and lawn maintenance was accomplished. The participants of Men's Fellowship did the church a huge favor by scraping and painting the exterior walls of the office spaces.

The Xerox copier in the Church Administrator's office was removed. It has been replaced with a smaller, more efficient desktop machine that prints and scans in addition to copying.

STEWARDSHIP COMMITTEE REPORT

In addition to financial gifts, volunteer contributions of time and skills have been outstanding, whether through committee service, special programs and presentations, participation in dinners, festivals, clean-up days, and other events, or ad-hoc responses to community needs.

We believe that stewardship is more than a campaign or a program; it is a pilgrimage. In this spirit, the committee looks forward to sharing its ongoing stewardship journey with you.

MISSION AND SOCIAL ACTION COMMITTEE REPORT

The Community Dinners inaugurated one year ago in January of 2012 are proceeding each month with the generous support and participation of many in our congregation. The invitation is always open for newcomers to volunteer and experience these inspiring events.

This past year, WISE and Second Growth were chosen in response to our committee's decision to build long-term relationships with local service organizations. El Salvador, and the Epilogos organization in particular, was chosen as our relationship for farther afield.

We continue our partnership with WISE, including the enormously generous response of many of our church members to the request for specific Christmas gifts for WISE families and their children. Looking forward, we have the opportunity to respond to the organization's request for bags for the Resource Room. A list of items needed in these bags will be forthcoming soon. For Second Growth, we are offering to host their training and teaching sessions at our church and are also exploring the possibility of providing their young clients with a meeting place.

Considering El Salvador, committee member Wendell Smith and Ron Bailey presented an afterchurch informational session on Epilogos and its partnership with Lebanon Riverside Rotary, which fields groups of workers to work alongside the villagers in building homes. The response from the congregation and the Mission and Social Action Committee was very positive and helped in our choosing this long-distance focus for our committee. We have committed to financial (and physical) support of this mission and plan an all-church informational session with the leadership of the Epilogos project in March. We are also exploring ways to involve the Church School and other members of the congregation.

In June, under the leadership of Barb and Steve Teeter, we hosted 33 college-age bikers in the Bike-and-Build program for two nights at our church. They worked for Habitat for Humanity on different sites during their stay. They were very enthusiastic about the meals provided by Trish Heatherton's cooking team, particularly the delicious vegan meal. Steve Teeter's breakfast pancakes were also a huge hit. The bikers look forward to wheeling back to us in 2013.

The garden on Bank Street is still going strong under the care of Ron Bailey. The harvest provided produce for the Baptist Church's food pantry and our Community Dinners.

Our church again hosted lunch after the Upper Valley CROP Walk in October. Many thanks to Jim, Linda, and Ashley Oronte for their fabulous cooking, and to many wonderful volunteers from our congregation for their support.

Among other ongoing initiatives were Neighbors in Need, One Great Hour of Sharing, Mother's Day Blanket Sunday, Father's Day Shelter Sunday, the Souper Bowl Sunday soup collection, and our Christmas Giving Tree for the Listen Center.

CHURCH HISTORY

As I begin my new journey as your church historian, I feel very apprehensive to be trying to fill the shoes of Carolin Bassett, but I will try! Thank you, Carolin, for being the historian for so many years.

January begins a new year, and congratulations were in order to Will Ögmundson, our organist, for his debut at Plymouth State University. He wrote the music to a new play based on the story of the Wild Swan. On January 22, we served the first of what we hoped would be a monthly Community Dinner at our church. It was very well attended, and with the guidance of Barb Laro and the whimsical table decorations of Marcia Corkins, we received many congratulations on a great, healthy meal. The following month on February 26, we served our second Community Dinner. We served twenty-five people who were grateful for our menu and cooking skills!

Sunday, February 12, was a busy day in the church. We received three new members to our church family, Cathy and John Bourgon and Susan Montmagny–welcome. After worship, approximately fifty-five people attended the annual meeting. We recognized the ten years of service from Trish and Todd Heatherton as church treasurers; Marcy Chong will be taking over that position. Todd Miller praised the members of our church as the reason why we were able to do so much restoration work on the church and parsonage without using money from the coffers. Most of the money was taken from the endowments of church members. We also voted in an amendment to the by-laws. The newly formed Finance Committee will oversee the church's financial affairs, including preparing an annual budget and approving expenditures over the budget. We have a new Music Committee, which will be responsible for developing an appreciation of music within the church. Warren Belding stepped down from the Board of Govenors after serving for so many years; we thank him for his long service. Rev. Silver commissioned the deacons during the meeting, and offered a blessing on all of us for the upcoming work we will be doing for the church and community. Carolin Bassett has also stepped down as church historian after fifteen years; we will miss her eloquence and grace. Thanks to Bob Moses for another efficiently run meeting.

Our choir took part in the Ecumenical Choir Festival held at the Lebanon United Methodist Church on February 12. The festival was dedicated to the memory of Beverly Gaylord, who was the organist and choir director here from 1978-2005. (Beverly died August 29, 2011.) Later in the month we also lost a long-time member of the church, Doris Morse.

As we ushered in the Lenten season, our church was also the host for a community Ash Wednesday service. Rev. Silver provided a daily Lenten meditation via email to anyone who wished to receive it, a nice way to begin the day. Lenten programming continued on March 7, when twenty-five people from our church participated in "The Power of Looking." This was a program at the Hood Museum led by church member and art historian Amy Driscoll. We met at the Hood to observe the Assyrian relief panels, which are over 3000 years old, and considered how to look at art and inspire our spirituality. On March 21, her husband Brian Clancy, also an art historian, led a related discussion of religious imagery. This session focused on Caravaggio's painting *The Entombment* (1603), offering another interesting and informative night. On March 18, the church family was invited to participate in the renewal of vows between Mary Turner and Michael Marcroft. Many friends and family filled our church for this momentous occasion. We also had a guest preacher that Sunday, the Rev. Andrew MacLeod, who leads the First Congregational Church (UCC) of East Millinocket. He was here to preach before members of a pastoral search committee in Bristol. In the afternoon, Bel Canto Chamber Singers gave their spring concert.

Our third Community dinner took place on March 26 and involved the younger members of our church helping out in various positions. In March Elizabeth Montmagny also started a handbell choir, which performed in worship on Palm Sunday, April 1. Well done!

The Lenten season continued with a prayer Mini-Retreat at the church on March 31. The Sunday school passed out paper bags again during this Lenten season, asking us to give up a little something every week and put the money in their bags. They collected them on Palm Sunday, April 1, and proceeds went to the Haven. Holy Week continued with the Maundy Thursday Tenebrae service and an Ecumenical Stations of the Cross Walk on Friday. The sunrise service on Easter Sunday was followed by an Easter breakfast sponsored by the Men's Fellowship, and then by the festival worship service in the Sanctuary.

April was also the second anniversary of Rev. Silver's arrival as our new minister. Therefore, according to our by-laws, the pastoral relations committee was charged to conduct a job evaluation. The congregation was given a form and asked to give their honest feedback; the committee reviewed the forms and reported back to the congregation. Also in April, Allison Schuster left her position as our church administrator to work in Geneva, Switzerland, for the Schwab Foundation. Good luck, Allison! Brian Clancy took her place as church administrator.

As a church, we have decided to become involved in mission closer to home. Peggy O'Neil of WISE and Robert Bryant of Second Growth both came to church in April to present to us what their organizations do.

In April we were saddened by the passing of Barbara Reed, a longtime member of the church. We lost two more beloved parishoners in May, Mary Turner and Donald Dickey.

The spring concert season continued the last week in April with a concert by Classicopia. We hosted Classicopia three more times during the months of April, May and June.

In early May the Senior Luncheon was attended by about fifteen people, who were serenaded again this year by the Superlatives from Lebanon High School. Rev. Silver also offered a threesession forum about the UCC organization and history. On May 27, we baptized Joseph and Lillian Henken and welcomed them to our church family.

The Diaconate also decided to resume our tradition of bringing communion to the home bound. Blanket Sunday was Mother's Day, May 13, followed in June by Shelter Sunday on Father's Day. Proceeds went go to Church World Services and Habitat for Humanity.

Work to strengthen the roof structure over the sanctuary was started in May and finished in early June. This was necessary for planned replacement of the sanctuary roof shingles.

A very busy June started by celebrating Trinity Sunday on June 3, when we received four more new members to our church community: John Gilliatt, Debbie and David Lemere, and Lee Ann Marsh. June 10 was Children's Day, which we celebrated with an ice cream social, games on the lawn and a Rail Trail Ramble. Each child was given a Bible and a book.

On June 16 the Women's Fellowship sold pies, watermelon, and lemonade at the Lebanon Alumni Parade. The next day we had a presentation after church by Laurie Harding and Dennis McCullough, who told us about a new community nursing initiative in the Upper Valley.

On June 19 we hosted a meal for the Dream Builders, who are helping flood victims in West Hartford and Sharon, VT. We served about sixty people. We also hosted 33 cyclists from the Bike-and-Build program, who helped on a Habitat for Humanity project in the area. We ended the month with another successful Community Dinner.

A wedding was held in June for Heather Hills and Jason Bergeron.

July ushered in more music in our concert series. The Upper Valley Music Center held a faculty concert for children, and our own Jen Corkins and her band, "Blue Road Crossing," held a concert to benefit her son Ryan's trip to Austria for the AFS-USA student exchange program.

In July we added a new dimension to our Community Dinners, asking anyone who had extra produce from their home gardens to bring it to the dinner to offer to our guests. The program continued into September.

On our last Sunday in July, we were treated to a beautiful rendition of the Lord's Prayer in voice and sign language by Elizabeth Montmagny. She moved to Montana to begin a teaching position on the Blackfeet Reservation. We were sad to see her go, but wish her luck and love.

August was ushered in with our Praise in the Park service on the Green, with the United Methodist Church. A week later on August 12, Beth Griffiths and Ken Steinke hosted our Summer Picnic, welcoming us to another wonderful afternoon at their home on Mascoma Lake.

Rev. Heidi Hoskin and Mark Rowell preached and led worship while Rev. Silver was on vacation in late August.

We kicked off the new program year on September 9 with a celebration of our children. We had a blessing of the backpacks, church school registration, lunch, and a bouncy house. The same weekend we resumed our Music at the Meetinghouse series with a concert in the Sanctuary by internationally known guitarist Peter Griggs.

And at the end of the month, despite inclement weather, the Applefest was once again very successful. We are so grateful to Barb Laro and Corrine Erskine for their leadership of this community event.

In September and October the church offered a chance get to know Jesus with a "Jesus: Then and Now" series, including sermons every Sunday on the subject and Forum discussions before worship. As part of the series, Brian Clancy led another art history discussion, "Looking at Jesus in Art," focusing on several images of Christ throughout history.

Funeral services were held on September 22 for Willmot "Bin" Lewis, Jr.

October started off with the CROP Walk on October 7. Our church hosted the luncheon again this year, serving everyone at the conclusion of the walk. Later in the month Classicopia returned for the first of three fall concerts, and a wedding was held for Katie Raymond and Benjamin Adams. On Halloween night, Christian Education volunteers handed out candy on the front lawn.

November ushered in a plethora of musical concerts, by the Upper Valley Music Center, Classicopia, and a benefit concert for the Upper Valley Humane Society. The Bel Canto Chamber Singers opened December with their winter concert.

Also in November, the Stewardship Committee presented short programs after worship on different aspects of ways we can respond to God's call of service. The community-wide Ecumenical Thanksgiving Service was held at our church this year, with an offering collected to benefit the Raven Food Pantry at First Baptist Church. We also baptized Zachary Smaha and welcomed him into our church community.

December's festivities began with the annual church Christmas party, sponsored by Women's Fellowship. The party was attended by about twenty people, who sang Christmas carols, had a Yankee swap, and enjoyed lots of goodies to eat.

We ushered in the Advent season on December 2 with the lighting of the first Advent candle and presentation of the first banner. The church Parlor was decorated for the season, as were the church pews. Wreaths on the front doors along with candles in the windows made our church a focal point in the city. Todd Miller did another magnificent job of stringing lights on the trees outside and giving us the most beautiful and fragrant Christmas tree in the Sanctuary.

The musical highlight of the month was a wonderful performance of Will Ögmundson's Christmas musical based on Tomie de Paola's "The Night of Las Posadas." Will deserves credit and thanks for this production, which was very well attended and received.

Also during Advent, Susan Reade presented a program about managing stress during the holidays. On December 10, a caroling group serenaded several homebound church members and came back for cookies and hot chocolate.
