The Pastoral Perspective

For some of us these days, the calendar is not so much a lived reality as it is an abstract concept. Whether we no longer have to go to work, or we are up to our eyeballs meeting the demands of the present crisis, familiar schedules and routines have gone by the wayside. At some level, we are all experiencing time differently.

All of this can be disorienting. One thing that can help us maintain our bearings is the liturgical calendar. Despite what is going on in the world around us, the church still observes its feasts and festivals. As always, at least in the Western church, Easter fell on the first Sunday after the Paschal full moon. This year, we celebrated our Lord's Resurrection on April 12. That means we will observe Pentecost on May 31.

What will it mean to mark the birth of the church in our sociallydistanced world? To paraphrase a question asked by our Jewish neighbors at the Passover Seder, "How is this year different from all other years?"

Well, we know that we won't be having birthday parties at church. And we know that many of us will be grieving all the losses and disruptions that the coronavirus has caused us. Traditions like Children's Sunday will have to be modified to meet the moment. But while none of us wished for all the disruption, I'd like to suggest that we take a moment to focus on the good that has arisen in the midst of the chaos.

We have had long-ago members and homebound friends join us for Sunday worship online.

We have employed and adjusted to new technology, and people have asked how we might expand our service offerings in the future so more people might be involved in worship. We have used this technology to meet and to socialize, even though we cannot gather together.

We have continued to support the wider community.

We have, in short, continued to be the church.

So in some ways, nothing is different this year.

But that is too facile an answer. The truth is, we're still learning how things have changed, and we can predict that things will continue to

COMMITTEE NOTES

CHURCH COUNCIL

John Gilliatt had little to report to Council for the **Board of Governors**. He has remained in contact with other Board members, but amid COVID-19 circumstances, not much progress has been made on specific projects in the past month. Wayne Braley plans to finish the chancel railings whenever possible. John noted that the date of the spring clean-up has not yet been set, but aside from a couple landscaping tasks, the anticipated workload is relatively minimal.

For Stewardship, Jon Scott again expressed gratitude for the offering contributions that have been sent into the church in recent weeks. He recognized that some may be unable to give as much as they have previously, while others may not be in a position to contribute anything. We have to anticipate a decrease in offering receipts as the virus crisis continues. Jon did point out a few changes to tax rules in the current climate, like reduced requirements for claiming charitable deductions and the waiver of mandatory IRA distributions.

For **Christian Education**, Nan Parsons has sustained connections with FCC's children by sending them several packages, two in virtual form and one as a physical mailing. (For the latter, she utilized some craft kits purchased in past years by Marcia Corkins.) Nan is wary of sending too much to the kids, who she notes may be overwhelmed by uncertainties and challenges of their remote learning programs. While she may try to do a short Zoom meeting at some point, she is sensitive to the fact that children are already spending a lot of time in Zoom meetings and other online formats for school.

Barb Teeter reported that the **Diaconate** had met via Zoom the previous week, although nothing significant needed to be brought to Council. The Deacons continue to follow up on their individual member contact lists. Council expressed deep appreciation for the meaningful cards and notes sent out in this difficult time.

The Mission and Social Action **Committee** has not met since early March, but Kathy Beckett hopes to call a meeting online in May. A new survey of the congregation about which mission beneficiaries FCC supports will be distributed soon. Kathy and Steve Silver explained the option of funding a community dinner at Listen, which Council agreed would be an appropriate gesture while we're unable to host our own monthly dinner. This would require a donation of \$680, which could be funded by the MSA account or, by extension, the Dole Trust's mission funds. Council unanimously approved the idea.

Corrine Erskine inquired about protocols for reopening the church once that is deemed safe. Mainly she wanted to ensure that we'll be able to clean the Sanctuary and other spaces thoroughly and regularly enough without overburdening Barb Teeter, who normally manages those tasks as Sexton.

For the **Music Committee**, Brian Clancy confirmed that virtually

every musical event through June has now been canceled. He noted that Bel Canto Chamber Singers had paid their full year's rental last fall; thus, we will apply a credit to their rental starting this fall. Brian also explained that the search for a new organist and choir director is essentially dormant due to the COVID-19 shutdown, as it makes little sense to hire someone until we resume live services. He noted that while we do have three declared candidates, none seems viable at this time. (Two of them, in fact, have not vet confirmed that they'll be located in the Upper Valley.)

Treasurer Terry Ellison reported an income shortfall relative to this point last year, mostly due to a decrease in stewardship collections and transfer amounts. Some of the church's expenses are also down, but many are unchanged by the building's closure.

In his **pastor's report** Steve Silver described settling into new weekly worship routines, as preparations for recorded services and Zoom meetings required changes in his sermon process and other practices.

COMMITTEE NOTES

Congregational Survey Coming Soon from MSA

It has been over four years since we last surveyed the congregation about the mission partners that FCC supports. The Mission and Social Action Committee seeks everyone's input now in order to update our mission priorities. A new survey will be distributed by email in the coming weeks.

To help us prepare the survey, we invite your suggestions of local, national, and global organizations that you feel FCC seems most naturally suited to support.

Steve thanked both organist Susan Sorensen and administrator Brian Clancy for their help in putting together services each week. Steve happily noted that participation in worship seems to be at or even above typical levels—a trend that has been reported at other area churches as well. Several people who haven't normally attended in person have joined the Zoom services.

Steve is preparing an application for the Payroll Protection Program,

which depends largely on Mascoma Bank's processing. He reported that while our investment portfolio has recently suffered, we've maintained stability with more balanced funds. Steve will participate on behalf of FCC in a conference call among the top 250 clients of United Church Funds. He has also continued in various non-FCC roles via Zoom.

The first FCC "social hour" online on Zoom was a success; more are planned with the help of volunteer moderators. Steve noted, however, that he and Brian genuinely miss having people in our building, and we all look forward to resuming our usual patterns of activity as soon as we can.

Following up on an earlier proposal, Steve noted that we will ring the church's bell at noon on April 22, joining a number of area churches and other institutions in observing the 50th anniversary of Earth Day.

DIACONATE

In April the Diaconate discussed the status of **Open Door Ministry** funding, in light of a slight decrease in receipts due to the suspension of services. The need for food and gas cards continues, however, and if needed this ministry could also be supplemented by the Dole Fund. Community dinners in March and April have been canceled, but it is possible we'll sponsor a dinner at Listen instead, which typically feeds about 140-150 people. Dawn Troutman remains willing to lead the June dinner for the Diaconate, should that go ahead.

The Deacons also checked in with each other about **congregational care** in this challenging time. In particular, support was expressed for Stacey Steele, who continues her work in health care while Dominic remains at home for school. In addition to following up with their individual member contact lists, the Deacons agreed the congregation might benefit from a mid-week "check-in" time on Zoom, perhaps on Wednesday evenings.

In his **pastor's report** Steve Silver noted that online worship activities had been fulfilling and successful for many. Participation has ranged between 30 and 55 for the various Zoom services (the highest being on Easter), with another 20-30 views logged weekly for YouTube videos. Several of those who have joined Zoom services haven't attended worship in person in some time.

Creation Care—A Priority for FCC, Our Community, and Our World Some Basic Tips for Greener Living and Resource Conservation

In the past several years, our congregation has tried to identify ways to be better stewards of God's creation. We've taken some steps as an institution to reduce energy and resource usage, and we're making **Creation Care** a priority of our campaign. If you'd like to support this effort at home, here are some suggestions:

Reduce material consumption and waste. Avoid single-use, disposable dishes and paper products. Reuse bags and containers. Print double-sided, use scrap paper, and make digital rather than printed copies when possible. Use rechargeable batteries. Recycle materials responsibly.

Reduce electricity usage. Turn off lights, computers, and other devices when not in use. Use Energy-Star appliances and light bulbs. Inform yourself about how your utility company generates energy.

Improve resource efficiency. Conduct an energy audit or consult an expert about insulation, appliances, and heating and cooling systems. Use a programmable thermostat. Reduce water usage and install water-saving plumbing fixtures. Combine weekly errands into fewer trips.

Create a healthier environment. Avoid toxic chemicals and cleaning products. Drive less, carpool/bike/ walk more. Grow houseplants, gardens, and produce at home. Compost organic food waste.
