The Pastoral Perspective

As I write this on Wednesday, November 4, I am struck yet again by how our faith can help us navigate the shoals and rapids of life. Like you, I presume, I am awaiting the final results from the election. And while I can check my phone for alerts, look at any number of websites, or tune in to the TV news, that will not cause the results to come any faster. My impatience will not change anything.

Scripture tells us that there are some things beyond our control. Of critical interest to the early church was when Jesus would return. People tried to discern patterns in the text and seek out hidden meanings, despite Jesus' admonitions that this knowledge was not for people to know. They (and we) would simply have to wait and, as they did that, lead faithful lives of service and Christian love.

Now, in writing this I am in no way trying to draw an equivalence between waiting for the return of Christ and expecting the final tallies from an electoral contest. But I do think there are some lessons that are transferrable from the former to the latter. We need to wait, but wisely. We need to live as if Jesus were going to return any minute now, not setting every care aside but turning our eyes to living in a such a manner to prepare ourselves to be held to account. So, rather than stew about those returns not coming in fast enough, we can focus on how we will live our lives and to pay attention to what we do know, now, in this moment.

If any one thing is clear from this year's election, it is that we are a polarized nation, with very different views of reality. This is not a healthy situation. While I am not going to counsel that we all simply just get along, we need to recognize our common humanity, that we all have one creator God and that his Son, Jesus, came to share the Gospel with all of us—even with those people with whom we disagree, those we dislike. As Christians, we are called to show the world what life in the Kingdom of God will be like, and I cannot imagine that it is meant to be marked by recrimination and fighting, name-calling and even anathematizing.

“For the Lord your God is bringing you into a good land... Do not say to yourself, ‘My power and the might of my own hand have gained me this wealth.’” —Deuteronomy 8:7,17

CHURCH COUNCIL

This fall Council has very carefully considered the question of our **re-opening**. Given local increases in covid cases and ongoing uncertainty of large public gatherings, it seems advisable to continue suspending services and other events through Advent and Christmas. Amidst general agreement, some suggested that we be clear about the timeline in order to manage expectations, without offering interim dates for reconsideration. Steve Silver added that committing to remote worship through Advent offers the flexibility of being creative, rather than having to wonder whether our familiar practices will be possible.

Nan Parsons has devised alternative plans for the **Children's Community Corner's** upcoming year, in lieu of in-person use of downstairs space. In an effort to keep the children physically connected to their space at FCC, she arranged to send small table-top fountains to everyone's homes. Nan will be trying to keep families involved despite COVID-19 restrictions, connecting by way of occasional Zoom meetings a half-hour prior to worship, in a loosely structured, broadly themed format. Chip Silver and Kailyn Rappaport will occasionally co-teach remote sessions; the older children would like to use some ideas from Marcia Corkins' time with the group. The kids will be focusing this year on Bible literacy and research skills.

The **Diaconate** has engaged in a hard but fruitful discussion about FCC's involvement with outside organizations and causes. While all

agreed that we should offer diverse opportunities for our congregation to get involved in larger social and political causes, it is problematic to take a public position without the approval of the congregation.

The **Mission and Social Action Committee** has considered how best to structure its membership and activity. This is a vital area of our ministry, important to everyone in the congregation, but it often is a challenge to determine who will do what. It is also uncertain how FCC will move forward from the pending dissolution of UVIP. The primary option offered by UVIP, joining the Granite State Organizing Project, does not seem to suit our wishes.

The **Board of Governors** got two estimates, from DR Key and TRJF, for the Parsonage sewer-line repair and replacement. DR Key has an established reputation in Lebanon and can do the work this fall, rather than waiting until the spring, and they would restore above-ground landscaping. Council approved this plan, to be funded by Dole Trust capital funds.

Treasurer Terry Ellison has noted no concerns on either the income or expense side of our budget through the third quarter. Stewardship has reached about \$65,000 toward our \$80,000 goal; contributions to the Open Door Ministry are only about half our 2020 goal, a drop resulting primarily from the suspension of in-person services. Terry has spoken with Valerie Nevel about various income and accounting questions, such as the designation of our annual Waldo Trust money.

For the **Trustees**, Valerie Nevel is watching the troubling economic outlook and its implications on our investments, trying to ensure that FCC will be prepared for any future hardship. She plans to have an online meeting with our United Church Fund advisors to discuss investment performance and market outlook. Valerie also asked whether we should bolster the MSA account balance with one large distribution of Dole Trust mission funds, rather than making transfers one-at-a-time as approved by Council. She noted that the Dole balance is now quite healthy and could be used more generously for mission purposes such as our Open Door Ministry.

Discussion considered our patterns of funding food and gas cards and other assistance, as well as a variety of mission-related contributions to Listen, Epilogos, UV Gear, and other organizations. Steve Silver noted that the terms of the Dole Trust don't explicitly prescribe spending a third on mission and two thirds on capital items, as we've traditionally thought. All agreed on the importance of funding as many mission purposes as possible, whether from Dole or

the general treasury. The Finance Committee will take up this issue and clarify Dole Trust policies.

Terry Ellison raised a related question about the state of our **escrow funds**, which reside in a discrete Mascoma Bank account. Many years ago, FCC's financial leadership recommended making annual contributions to this fund to be held in escrow for various needs, such as building repairs, organ maintenance, and pastor sabbatical expenses. Those allotments have not been made for several years, even though we continue to account for them in our annual budgets, and all agreed that we should resume this plan for unexpected expenses. The Finance Committee will determine the appropriate allocations and make recommendations for 2021.

Jon Scott noted for **Stewardship** that our annual fall pledge appeal would have to consider our circumstances, as suspension of in-person worship will likely continue for some time. While we have to move forward with our usual planning, Jon recognized that we need an approach that suits the uncertainty around covid-19 and related economic distress.

For the **Music Committee**, Brian Clancy reported that Ernie Drown is settling in well, having renovated the music office downstairs and gotten accustomed to our weekly recording routines. Ernie is looking forward to doing more in coming weeks, particularly in trying to reach out to the choir. His hire seems to be an excellent fit so far. Brian also confirmed that no public concerts would be held at FCC this fall, but a couple performers have arranged

to make recordings in our Sanctuary, a limited and safe building use that helps maintain our connections to the musical community.

Speaking as Church Administrator, Brian raised the question of whether we might again host the bi-monthly **WIC clinics**, as that program has tentatively considered resuming in-person operations. It seems that the program's staff would be responsible about health and safety protocols and pose minimal risk to our church community, but having numerous families pass through our building does entail some unpredictability. With the congregation still absent from the building, the primary risk would be to church staff.

In his **pastor's report** Steve Silver observed the benefits of offering adult-education options on Zoom, which allows more participants and easier scheduling than in the past. In worship and other areas, we will continue some online offerings even after we reopen. Steve has been in touch with the new interim pastor at West Lebanon Congregational and the new pastor at Lebanon United

Methodist, and the First Baptist congregation will finally return to their building sometime after the new year. And all are invited to join the annual meeting of the Grafton-Orange-Sullivan Association, to be held on Zoom on November 8.

Steve worked with the family of longtime FCC member Laura Place to accommodate her funeral in our sanctuary on October 10, with firm attendance limits and precautions for COVID in place. While we were glad to offer the service and all went smoothly that day, it did bring some logistical complexity, suggesting the challenges of returning to in-person worship. He thanked the Deacons and congregation for our successful outdoor services, inviting feedback, should we offer those again.

Steve again expressed his gratitude to the congregation for being so supportive and collaborative during our ongoing shutdown. He offered encouragement as we head deeper into the fall and winter, which may well pose challenges as we continue to deal with the coronavirus and its myriad consequences.

DIACONATE

In September the Deacons talked about FCC's role in outside projects in which the lead organization—e.g., the Graham Ministry or Black Lives Matter—may advocate issues that go beyond positions formally taken by our congregation. It was suggested that wider congregational discussion take place around issue advocacy that is congregation-initiated. The Deacons recognized that general information on such organizations and initiatives could be provided without indicating any institutional endorsement from FCC.

Surveying congregational concerns, the Deacons expressed support for Harriet Oman, Larry Doyle, and Jim Oronte, all of whom continue to deal with various health issues.

Longtime member Ardell Mansfield has now moved from her home to Harvest Hill at APD. The Deacons also thanked Nan Parsons and her crew for sustaining the Children's Community Corner.

The Deacons also welcomed Ernie Drown to FCC's staff, with some introduction from Steve about Ernie's background and experience. Ernie looks forward to getting to

know the congregation and invited comments. Several have expressed interest in having more music for Zoom services, possibly requiring better equipment.

While three outdoor services this fall have gone well, the Diaconate discussed our ability to welcome walk-ins and the limitations of cold weather. Laura Place's memorial service drew about 65 attendees but highlighted our capacity limits and the participants' inability to interact socially. It was agreed these services should remain a rare exception until the spring of 2021.

Black Lives Matter Vigils in the Upper Valley

All are encouraged to participate in one or more of these weekly **Black Lives Matter** vigils for racial justice. FCC's Church Council and the Mission and Social Action Committee have affirmed this as a relatively easy but visible and important way for all members of our congregation to offer our Christian witness to the many tragedies of systemic racism and join in demanding significant cultural change. Bring your own signs promoting racial justice, awareness, and action—and spread the word among your friends and social networks.


